SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR PARK MEDITERRANIA OWNERS ASSOCIATION

THIS SECOND AMENDMENT is made on this 151 day of 304, 2005, by the owners of Lots within Park Mediterrania Owners Association with reference to the following:

RECITALS

- A. This document is recorded for the purpose of amending that certain "Declaration of Covenants, Conditions and Restrictions," as the same has been supplemented or amended from time to time, hereafter referred to as "Declaration", which was recorded on July 2, 1979, In Book 9719 Page 430 of Official Records of the County of San Bernardino, State of California, for the property more particularly described on Exhibit "A" attached hereto.
- B. The property described on Exhibits "A" shall hereinafter be referred to as the "Property." This document amends the Declaration to remove in its entirety the First Amendment which was recorded on October 24, 1985, as Instrument 85-265820 of Official Records of the County of San Bernardino, State of California and replaced with the Second Amendment as specified below:
- C. This Second Amendment has been adopted by more than the required minimum of seventy-five percent (75%) of owners of Lots within the Property under the provisions of Article 10, Section 10.04 of the Declaration, which requires Amendments to be made by the affirmative vote or written consent of seventy-five percent (75%) of the owners of Lots in the Property. The owners have authorized this Amendment to be executed and acknowledged on their behalf by the President and Secretary of Park Mediterrania Owners Association (hereinafter "Association") as the representative of the Board of Directors of the Association and as the representatives of the individual owners of Lots within the Property; shall be certified by the Secretary of the Association; and shall become effective upon the recording thereof with the Office of the County Recorder of San Bernardino County, California.

DECLARATION

NOW THEREFORE, the Declaration is hereby amended as follows:

- The Amendment to the Declaration of Covenants, Conditions and Restrictions for Park 1. Mediterrania Owners Association which was recorded on October 24, 1985, as Instrument 85-265820 of Official Records of the County of San Bernardino, State of California is to be removed in its entirety and replaced with the following:
- Article VII, Section 7.01(a) of the Declaration shall be amended to read as follows: 2.

7.01(a) Water, gas, electricity, refuse collection, other necessary utility services, maintenance, repair and replacement of landscaping and any other facilities of the common area.

Association shall establish reserve accounts for the sole purpose of maintaining, repairing and replacement of the roofing material on all buildings, including such subsurface roofing materials as are consistent with good roofing maintenance practice; and shall paint, maintain and make minor repairs to the exterior surfaces of all buildings within the project, excluding replacement of exterior wood trim, which will be the sole responsibility of the Lot Owners.

In all other respects, the Lot Owners will be responsible for the maintenance, repair and replacement of all components within their separate interest Lots as more particularly described in California Civil Code §§ 1351 and 1354. Each Lot Owner shall be responsible for the maintenance, repair and replacement of the structural elements of the Dwelling, including, without limitation, the structural support portion of the roofs.

- 3. Except as expressly amended herein, the remaining portions of the Declaration shall remain in full force and effect.
- The Certification of the Secretary of Park Mediterrania Owners Association as to the 4. approval of the Second Amendment is attached hereto as Exhibit "B".

IN WITNESS WHEREOF, this Amendment is executed on the day and year hereinabove written by the undersigned President and Secretary of Park Mediterrania Owners Association as representatives of the owners of Lots within the Property.
